IMPORTANT REMARKS ON THE PERSONAL DATA SUBJECT APPLICATION FORM AND RIGHT OF PETITION:

Right of Petition of Personal Data Subject

Article 11 of the Law on the Protection of Personal Data No. 6698 ("Law on KVK") regulates that the personal data subjects may request the followings:

- a. Learning whether the personal data have been processed or not
- b. Claiming personal information if personal data is processed
- c. Learning the purpose of his/her data processing and whether this data is used for intended purposes
- d. Learning the third parties to whom his/her personal data is transferred at home or abroad
- e. Demanding the rectification of incomplete or inaccurate data, if any
- f. Requesting the erasure, destruction or anonymization of personal data if the reasons for processing have been disappeared despite the fact that the data were processed in accordance with the Law on Personal Data Protection and other relevant provisions of law
- g. Claiming that the correction, erasure or destruction of personal data be notified to third parties to which the personal data is transferred
- h. Objecting to any application response against himself/herself, resulting from the analysis of processed data exclusively by the automatic systems
- i. Claiming compensation in case of suffering loss due to illegal processing of his/her personal data

Exceptions to Right of Petition

Personal data subjects, pursuant to Article 28 of the Law on KVK, may not claim the foregoing rights:

- a. Processing the personal data for the purposes of investigation, planning, and statistics by anonymizing with official statistics
- b. Processing personal data within the context of artistic, historical, literary or scientific purposes or freedom of speech provided that the personal data does not breach the natural defense, national security, public security, public order, economic security and confidentiality of private life or personal rights, and does not constitute a crime
- c. Processing the personal data within the scope of preventive, protective and intelligence operations executed by state institutions and organizations so authorized by the law to ensure national defense, national security, public safety, public order, and economic security
- d. Processing the personal data by judicial or enforcement authorities in relation to the investigation, proceedings, litigation or execution procedures

Personal data subjects, pursuant to Article 28/2 of the Law on KVK, may not claim their other rights, except the right to claim damage, in the following cases:

- a. Processing personal data required for prevention of committing an illegal act or criminal investigation
- b. Processing of personal data publicized by the personal data subject
- c. Processing personal data being required for disciplinary investigation, prosecution and conducting supervisory or regulatory duties by the authorized state institutions and organizations, and professional public organizations by the power granted by the law
- d. Processing personal data required for protecting the economic and financial interest of the State with regard to the budgetary, tax-related and financial issues
